**ORDER :**

Whereas vide reference 1st read above, the Government of India have enacted the Rights of Persons with Disabilities Act, 2016;

2. And whereas vide G.O. 2nd read above, the Andhra Pradesh Rights of Persons with Disabilities Rules, 2023 have been notified;

3. And Whereas Section 66 of the said Act, provide for 'every State Government shall, by notification, constitute a body to be known as the state Advisory Board on disability to exercise the powers conferred on and to perform the function assigned to it, under the Act;

4. Now, therefore, the Government of Andhra Pradesh, constitute the State Advisory Board on disability;

5. Accordingly, the following Notification will be published in the Extra Ordinary issue of the Andhra Pradesh Gazette, Dated: 04.05.2023.

**NOTIFICATION**

In exercise of the powers conferred under Section 66 of the Rights of Persons with Disabilities Act, 2016 read with Rule 25 of the Andhra Pradesh Rights of Persons with Disabilities Rules, 2023, the State Government hereby constitute the State Advisory Board on Disability consisting of the following members as required under Section 66 of the said Act:

A Member of the State Advisory Board nominated under clause (e) of subsection (2) of section 66 of the Rights of Persons with Disabilities Act, 2016, shall hold office for three years from the date of his / her nomination.

The State Advisory Board shall meet at least once in every six months.

The Terms and conditions of service of members, disqualification, vacation of seats, meetings of State Advisory Board on Disability and functions of State Advisory Board on Disability shall be as provided under relevant sections of the Rights of Persons with Disabilities Act, 2016 in respect of State Advisory Board on Disability.

The Director, Welfare of Differently Abled, Transgender & Senior Citizens Department, Government of Andhra Pradesh, shall take necessary action accordingly.
