**II. Application procedure :**

**1. Laptops**

**(a) Eligibility :**

- ❖ Bonafide students studying Graduation and above courses and Diploma in ITI/Polytechnic regularly.
- ❖ Annual Income of family should not be more than Rs.3.00 lakhs
- ❖ 40% & above Disability and eligibility as specified in RPwD Act, 2016.
- ❖ Sanctioned once in a life time.

(b) **Documents required :**

- ❖ Disability Certificate.
- ❖ Aadhar Card
- ❖ SSC Certificate
- ❖ Caste Certificate in case of SC/ST/BC
- ❖ Passport size photo
- ❖ Latest Income Certificate/ BPL Ration Card.
- ❖ Bonafide Certificate from the institution.

**2. Touch Phones :**

(a) **Eligibility :**

- ❖ Intermediate Pass.
- ❖ Age 18 years and above.
- ❖ Knowing Sign Language.
- ❖ 40% & above Disability and eligibility as specified in RPWD Act, 2016
- ❖ Annual Income of family should not be more than Rs.3.00 lakhs.
- ❖ Sanctioned once in a life time.

(b) **Documents required :**

- ❖ Disability Certificate.
- ❖ Aadhar Card
- ❖ SSC Certificate (Age proof)
- ❖ Sign Language Certificate from the Audiologist/Head Master of the Deaf School.
- ❖ Caste Certificate in case of SC/ST/BC
- ❖ Passport size photo
- ❖ Latest Income Certificate/ BPL Ration Card.

**3. Motorized Three Wheelers :**

(a) **Eligibility :**

- ❖ Age between 18-45 years
- ❖ 70% & above Disability
- ❖ Annual Income of family should not be more than Rs.3.00 lakhs.
- ❖ Bonafide students studying Graduation and above courses regularly.
- ❖ Self employed including Agriculture & Allied activities or wage/salary employed for minimum one year period with 10<sup>th</sup> Class Pass.

- ❖ Should acquire valid driving licence for driving an adopted vehicle (earlier it was invalid carriage) issued under Motor Vehicle Act within two months from the date of selection.
- ❖ Sanctioned once in a life time.

**(b) Documents required :**

- ❖ Disability Certificate.
- ❖ Aadhar Card
- ❖ SSC Certificate
- ❖ Caste Certificate in case of SC/ST/BC
- ❖ Passport size photo
- ❖ Latest Income Certificate
- ❖ Bonafide Certificate from the institution for student category.
- ❖ Self/Wage employment Certificate from concerned MPDO/ Municipal Commissioner for Self/Wage Category.
- ❖ Self Declaration on punishment for fraudulently availing any benefit meant for persons with Disabilities.
- ❖ Self Declaration that he/she has not availed the benefit of Motorized Vehicle earlier from the Government, Government Agency/ Private Agency or any other source and he/she should not have any Motorized Vehicle two/three/four wheeler of his/her own.

**4. Hearing Aids :**

**(a) Eligibility :**

- ❖ Annual Income of family should not be more than Rs.3.00 lakhs.
- ❖ 40% & above Disability and eligibility as specified in RPWD Act, 2016.
- ❖ Sanctioned once in three years.

**(b) Documents required :**

- ❖ Disability Certificate/Age proof in case of Senior Citizens.
- ❖ Aadhar Card
- ❖ Audiogram Certificate.
- ❖ Caste Certificate in case of SC/ST/BC
- ❖ Passport size photo
- ❖ Latest Income Certificate/ BPL Ration Card.


**5. All Other Aids & Appliances :**


**(a) Eligibility :**

- ❖ 40% & above Disability and eligibility as specified in RPwD Act, 2016.
- ❖ Sanctioned once in three years.
- ❖ Annual Income of family should not be more than Rs.3.00 lakhs.

**(b) Documents required :**

- ❖ Disability Certificate/Age proof in case of Senior Citizens
- ❖ Aadhar Card
- ❖ Caste Certificate in case of SC/ST/BC
- ❖ Passport size photo
